FINAL ORDER

12.03.2020

1. At the outset, it is made clear that this Final Order is passed by the Fee Regulatory Committee, consisting of the Chairman as well as Mr. R. C. Raval, the Member of the committee. As per the Provisions contained in Rule 5(5) of Gujarat Self-Financed Schools (Regulations of Fees) Rules, 2017, the quorum at the meeting of the Committee shall be atleast 2/3rd Members of the total strength of the Committee. If there is no quorum at the meeting, the same shall be adjourned for half an hour. Thereafter, the meeting shall be held for the transaction of its business. The total strength of the Committee is 5 and for the purpose of the quorum at the meeting at least 3 Members of

the Committee should remain present. However, only the Chairman and 1 Member remain present and they have waited for half an hour. Since, no 3rd Member has come to the meeting, as per the Provision of Rule 5(5), the meeting is held by the Committee consisting of the Chairman and 1 Member for the transaction of its business.

- 2. Zebar School for Children, Opp. Suyog Apartments, Behind Cooper Stone, Off Thaltej- Shilaj Road, Thaltej, Ahmedabad- 380059, has submitted its proposal for the academic year 2020-21, for Pre-Primary to Higher Secondary Sections (CBSE- English Medium) along with certain documents. After considering the said proposal, the FRC has passed the provisional order on 10.02.2020, determining the provisional fees for the academic year 2020-21 for Pre-Primary to Higher Secondary Sections (CBSE-English Medium).
- **3.** The said provisional order was duly received by the school and on receipt of the said provisional order, the FRC has sent a letter dated 11.03.2020 stating therein that the school has no objection against the fees as approved by the FRC. The school has also requested the FRC to issue the Final Order in accordance with the provisional order.
- **4.** In view of the provisional order passed by the FRC on 10.02.2020 and in view of the school's letter dated 11.03.2020 agreeing with the fees determined in the provisional order, the FRC hereby determines the final fees in accordance with the provisional order for the academic year 2020-21 for Pre-Primary to Higher Secondary Sections (CBSE- English Medium) as under:-

Terms and Conditions:

- 1. It is directed that the school is not permitted to collect fees for the year 2020-21, more than the final fees determined for the year 2020-21.
- 2. It is further made clear that the school is not permitted to collect fees under any other head including under the head of Admission Fees except one month fees by way of admission of fees only in case of new admission and thereby causing any extra burden on the students.
- 3. Any other fees collected under the head Transportation, uniform charges, meal or food charges or other activities should be optional and the same should not be made compulsory. The details of such fees should also be furnished to the Committee.
- 4. Any violation of this order shall be dealt with by the Committee in accordance with law, on being brought to the notice of the Committee by any aggrieved party.
- 5. The FRC has considered the final fees for academic year 2019-20 and after giving rise of 5% in the said fees, the school is entitled to collect the fees for the academic year 2020-21 as finally determined by the FRC.

- 6. Since the school has submitted the proposal for the academic year 2020-21, 2021-22 and 2022-23, the final fees determined by the FRC for the academic year 2020-21 are equally applicable to the academic year 2021-22 and 2022-23. If the school wants any increase in the fees for the subsequent two years i.e. 2021-22 and 2022-23, the school shall have to approach the FRC for approval of such fees.
- 7. The school is directed to place the order determining final fees on its notice board as well as on the website of the school.
